
In addition, PPL Electric notes that pursuant to Paragraph 2 of the March 26<sup>th</sup> Prehearing Order issued in this proceeding, **“You may lose the case if you do not take part in this hearing and present evidence on the issues raised. Your case may be dismissed ‘with prejudice’ which means that you will be barred from filing another complaint raising the same claim(s) and issue(s) presented in the dismissed complaint.”**

The Complaint indicates that a Protection From Abuse (“PFA”) order has been issued for the Complainant’s personal safety or welfare. Comp. ¶ 6. As such, PPL Electric has omitted information from this filing that could be used to determine the Complainant’s location and contact information.
