

Dear Secretary Homsher,

Be advised that I have been contacted by Melvin Hart, the owner and operator of M S Hart Enterprises, LLC. He received notice that the Public Utility Commission has sanctioned the LLC for Failure to Report Positive Operating Revenue at the above docket number. Be advised that Mr. Hart has provided the 2025 Assessment Report Motor Carriers Form by the March 31st, 2026 deadline. I am providing a copy of the Form that he provided which shows that although he received operating revenue of \$283, 918, all that income would be exempt under exemption number four (4) in that the materials that he transported were road construction materials used solely for private or public road projects and with a dump truck. Mr. Hart has been filing this form the same way for at least ten (10) years and there has never been an issue. This is the only materials that he transports in his vehicle that's why it includes all of his income. He also provided payment sheets from Grannis Brothers, who he subcontracts with to perform said work. You should have the documents verifying what my client from Grannis Brothers. As you should know, Grannis Brothers has a contract with the State for many road projects and my client is a driver that assists them in taking the material that they need to pave or fix the road. I would submit that based upon the revenue as provided by 66 Pa.C.S § 102, subsection 4, that the total amount of revenue of \$283, 918 be exempt from any fee to the Public Utility Commission. I

would ask that you contact me or set up another conference so we can discuss this matter further.
But we do object to the revocation of Mr. Hart's certificate as he has complied with the statutes.
