Dear Secretary Homsher,

Please accept this letter as formal notification that Champions Recovery and Investigations is seeking to ensure full compliance with the Pennsylvania Public Utility Commission (PUC) regulations regarding towing and transport authority.

Historically, our primary business operations have consisted of services that fall under exempt categories. Specifically, our revenue has been derived from:

Transportation of Stolen or Repossessed Vehicles.

Transportation of Wrecked or Disabled Vehicles.

We understand that these specific activities are exempt from PUC rate and certificate regulations.

However, as of the start of the 2026 calendar year, Champions Recovery and Investigations has expanded its service offerings to include transportation that would be non-exempt revenue.

We recognize that our transportation expansion constitutes non-exempt revenue and requires the appropriate PUC motor carrier authority.

## Reporting and Compliance


We are committed to maintaining transparent and accurate records. Please be advised of the following:

**Authority Status:** We are submitting this notice to acknowledge our requirement to hold PUC authority as a towing company for our non-exempt transport services.

**Financial Reporting:** All non-exempt revenue generated from transport during the 2026 calendar year will be accurately documented and reported to the Commission for the 2026 assessment year.

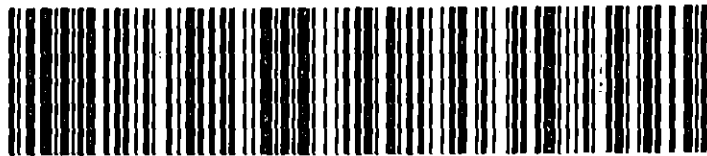
