SECOND ORDER EXTENDING TIME TO OBTAIN COUNSEL

On December 1, 2025, Guardian NEMT, LLC (“Guardian”) filed an application for motor common carrier of persons in paratransit service with the Pennsylvania Public Utility Commission. In its application, Guardian requested authority to transport elderly and disabled persons from points in Montgomery County to points in Pennsylvania and return.

On January 12, 2026, a joint protest was filed by Bux-Mont Transportation, Inc., Easton Coach Company, Suburban Transit Network, Inc., and Tri County Transit Service, Inc. (“Joint Protestants”)

On March 4, 2026, a prehearing conference was held with Edward Garbrah for Guardian and counsel for the Joint Protestants in attendance.

On March 6, 2026, an order was issued directing Guardian to obtain counsel and have that counsel enter an appearance in this matter on or before May 4, 2026. The order further stated that if Guardian failed to comply with the order and failed to request additional time to resolve the joint protest, the application may be dismissed.

On May 1, 2026, the Joint Protestants filed a request for an extension of the deadline for Guardian to obtain counsel by at least two weeks. The request was also emailed to the undersigned. The request and indicated that both Guardian and the Joint Protestants agreed to the extension to explore potential resolution of the dispute.

On May 4, 2026, an order was issued extending the deadline for Guardian to have counsel enter an appearance in this matter from May 4, 2026 to May 22, 2026.

On May 19, 2026, Guardian requested, via email, an extension of the deadline to obtain counsel from May 22, 2026 to June 5, 2026. The Joint Protestants did not oppose the extension request.

ORDER

THEREFORE,

IT IS ORDERED:

1. That the request to extend the deadline for Guardian NEMT, LLC (i.e., Edward Garbrah) to obtain counsel in this matter is granted.
2. That Guardian NEMT, LLC (i.e., Edward Garbrah) shall have until June 5, 2026 to obtain counsel in this matter and have counsel enter their appearance.
3. That if an attorney does not enter their appearance for Guardian NEMT, LLC by June 5, 2026 and does not request additional time to resolve the joint protest, Guardian NEMT, LLC's application at Docket No. A-2025-3059020 may be dismissed.
