INTERIM ORDER
SETTING DEADLINE FOR RESPONDENT TO FILE RESPONSE TO PETITION FILED BY
COMPLAINANT

Lauren Zonca (Complainant) filed a Formal Complaint (Complaint) with the Pennsylvania Public Utility Commission (Commission) against Metropolitan Edison Company (Respondent or Company) at Docket number C-2023-3041619.

The hearing convened as scheduled and was concluded on October 29, 2025. Upon conclusion of the hearing, the parties were advised that an order would be entered addressing a briefing schedule. The Parties were advised that the filing of briefs would be permitted but would not be required.

On November 20, 2025, an Interim Order was entered providing a deadline for the filing of main briefs of January 30, 2026 and for any reply briefs of February 13, 2026.

Complainant filed a main and reply brief. Respondent filed a main brief in this proceeding.

On February 13, 2026, Complainant filed a Petition To Re-Open the Proceeding For the Purpose of Taking Additional Evidence (Petition). Complainant averred that while preparing her reply brief, she realized she had not entered the following into evidence during the hearing:

1. The PUC Implementation Order of 2009.
2. The MADRI slide presentation of March 5, 2009 by Pizzingrilli and Rooney.
3. Interrogatories on 57.255(a).
4. Senate and House Journals from the time of Act 129's passage.
5. Act 129 of 2008.
6. Utility Tariff for Met-Ed.
7. Thomas Yewcic Testimony.

No Notice to pleas was provided with the Petition and no responsive pleading was filed by Respondent.

Under the circumstances, the following Interim Order will be entered.

THEREFORE,

IT IS ORDERED:

1. That the Respondent may file a responsive pleading to the Petition To Re-Open the Proceeding For the Purpose of Taking Additional Evidence filed by Complainant, to include a WORD version provided to the undersigned presiding officer, no later than June 26, 2026.
