We received a tentative order for cancellation of certificate of Public Convenience for failure to report positive operating revenue. We do have Positive revenue showing on our 2025 Assessment Report. We are requesting that our PUC Authority is **NOT** canceled.

Through this process and reviewing our 2025 Assessment, the majority of our intrastate operations are exempt materials listed as #4, Waste, excavated, and road construction materials hauled in triaxle dump trucks. However, we have started hauling Antiskid and recycled material with our 5 axle tractor trailers that pull dump trailers and learned that these materials are not exempt and need to be reported.

In the past, we have filed no positive revenue because all the materials we hauled fell under the exemption. But with the tractor trailers and hauling some newer materials that are not exempt we would need to continue to have our PUC Authority. We are asking to please **NOT** cancel our PUC Authority.
