**BKV’S WITHDRAWAL OF OPPOSITION TO APPLICATION**

Pursuant to 52 Pa. Code § 5.94(b), BKV Operating, LLC (*BKV*) withdraws its opposition to the application filed in these proceedings, including that contained within BKV’s protest, and states the following.

On February 6, 2026, UGI Utilities, Inc. – Gas Division (*UGI Gas*) filed its application in the instant proceedings (*Application*). On March 9, 2026, BKV filed a combined petition to intervene and protest. On March 19, 2026, the Pennsylvania Public Utility Commission issued its prehearing conference notice identifying The Honorable Alphonso Arnold III as the Administrative Law Judge assigned to the proceeding (*ALJ*).

On March 27, 2026, BKV filed a combined amended petition to intervene and protest (*Petition*), and UGI Gas filed preliminary objections, requesting that BKV’s Petition be dismissed (*Preliminary Objections*). On March 30, 2026, UGI Gas filed a motion for leave to answer the Protest (*Motion*) and corresponding answer and new matter (*UGI Answer*).

As of the date of this filing, the ALJ has not ruled on the Petition, the Preliminary Objections, or the Motion because, pursuant to requests from BKV and UGI Gas, the ALJ has held the proceedings in abeyance. During the intervening abeyance, BKV entered a settlement that resolved BKV's opposition to the Application.

Pursuant to the settlement, BKV hereby withdraws its opposition to the Application, including that contained within the Petition. Pursuant to the settlement, UGI Gas will also be withdrawing its Preliminary Objections, Motion, and UGI Answer. In that regard, BKV requests that the ALJ grant BKV party status as an intervenor based on an unopposed petition to intervene.
