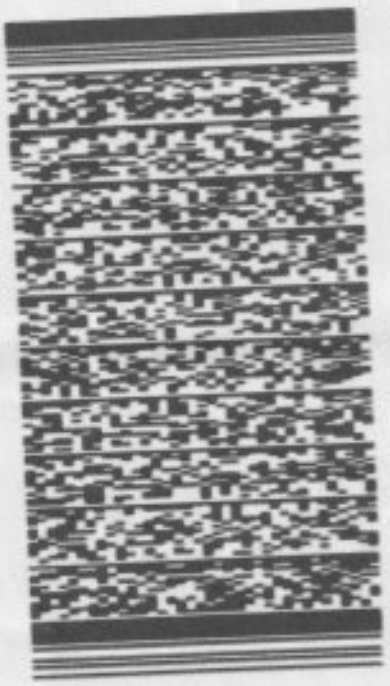



approximations, but bank accounts and loan balances should be exact amounts (rounded to the nearest dollar).

- b. All relevant assets and debts are to be included (for example: vehicle loan balances/vehicle asset value, lease expenses, etc.).
- c. The information provided is also to be strictly limited to assets and debts held by the applicant (Be Safe Transport LLC), and not the individual member(s). Any property and accounts listed must be registered or titled to the corporation. Bank accounts must be in the name of Be Safe Transport LLC. Vehicles must be registered to Be Safe Transport LLC. Property must be titled to Be Safe Transport LLC. If these items are not in the name of Be Safe Transport LLC, then they should not be included on the balance sheet.

If you have not fully funded and equipped the business, now is the time to do so (before re-submitting your corrections). Applicants lacking suitable finances, resources, and equipment will be denied authority.

- d. In order to fully assist the Commission in determining your financial fitness, please provide supporting documentation for the statement of financial position (balance sheet). Acceptable means of support include current copies of bank statements (account numbers may be redacted), and notarized/official statements of account balances/ownership provided by bank officers (with current contact information). Any and all claimed vehicles or land/buildings must also include proof of ownership/registration vehicle titles, vehicle registrations, property titles, purchase agreements, etc.
- 5.) You are encouraged to enlist professional financial assistance if you experience difficulty in constructing your statement of financial position. Be advised that failing to provide an acceptable financial statement is sufficient grounds for the denial of your application.

PLEASE PROVIDED A THOROUGH TYPED RESPONSE TO THESE QUESTIONS ON A SEPARATE SHEET OF PAPER

- Every six (6) months thereafter
 - Immediately following any reported accident or moving violation
- Driver history reports and verification records are maintained electronically and/or in secured personnel files for a minimum of five (5) years.

3.) Quarterly Vehicle Maintenance Plan

Be Safe Transport LLC maintains a quarterly preventative maintenance program for all company vehicles.

Quarterly maintenance includes:

- Brake inspection
- Tire inspection and tread measurement
- Oil and fluid checks
- Steering and suspension inspection
- Lights and signal inspection
- Wheelchair securement equipment inspection (if applicable)
- Battery testing
- HVAC inspection
- Safety equipment inspection
- Vehicle sanitation and interior condition review

Additional maintenance procedures include:

- Daily driver pre-trip inspections
- Immediate repair of safety-related defects
- Maintenance logs maintained for each vehicle
- Repairs completed by qualified mechanics or service facilities

4.) Revised Statement of Financial Position

Be Safe Transport LLC intends to transport individuals in paratransit service from points in the Counties of Berks, Bucks, Chester, Lehigh, and Montgomery to points throughout Pennsylvania, and return.

2.) Driver Regulations Compliance (Title 52 Pa. Code §§29.501–509)

a.) Hiring Standards for Drivers

Be Safe Transport LLC maintains hiring standards to ensure the safety and professionalism of all drivers operating under company authority.

Hiring Standards Include:

- Valid driver's license
- Clean driving history review
- Criminal background clearance
- Drug-free workplace compliance
- Professional customer service skills
- Ability to safely assist passengers with mobility needs
- Completion of company orientation and training

Drivers must be at least 25 years old to operate under Be Safe Transport LLC authority.

b.) Criminal Background Checks

Be Safe Transport LLC conducts criminal background checks through approved state and/or third-party background screening providers prior to employment.

Criminal background checks are conducted:

- Prior to hiring
- Annually thereafter
- Any time the company becomes aware of conduct affecting driver eligibility

Disqualifying offenses may include:

- Violent crimes
- Sexual offenses
- Drug trafficking offenses
- Crimes involving abuse or neglect
- Theft or fraud-related offenses
- DUI convictions within the past five years
- Felony convictions involving passenger safety concerns

Criminal background check records are maintained electronically and/or in secured personnel files for a minimum of five (5) years.

c.) Driver License / Driver History Checks

Driver license and motor vehicle history checks are conducted through PennDOT motor vehicle records (MVR) and authorized reporting systems.
