Re: PPLICA Petition to Intervene in the PPL Electric Utilities Corporation Proceeding for a Declaratory Order to Terminate Controversies Concerning PPL's Certificated Rights to Provide Service in the Borough of Olyphant and Related Transition Charges
Docket No. P-00021986

On November 6, 2002, PP&L Industrial Customer Alliance ("PPLICA") filed the above-referenced Petition with the Commission. The purpose of PPLICA's Petition is to obtain Commission approval to intervene with full-party status in the PPL Electric Utilities ("PPL") above-captioned proceeding wherein PPL is seeking a declaratory order to terminate controversies concerning PPL's certificated rights to provide service in the Borough of Olyphant and related transition charges ("PPL Proceeding"). As of June 27, 2003, jurisdiction in the PPL Proceeding has been returned to the Commission from the United States District Court for the Middle District.

On November 26, 2002, PPL filed with the Commission an Answer to PPLICA's Petition to Intervene stating that PPL does not oppose PPLICA's participation in the PPL Proceeding as an intervener. Accordingly, PPLICA's Petition to Intervene is unopposed by all parties to the PPL Proceeding.

The Commission now grants PPLICA's Petition to Intervene; thereby, providing PPLICA with full-party status in the PPL Proceeding. 
