Please accept this letter as a formal request to abandon **Insight Sourcing Group LLC (“Insight”) Electric Generation Supplier License as Broker/Marketer** in the State of Pennsylvania effective upon Commission approval/issuance of Secretarial Letter.

On 28<sup>th</sup> October 2021, Insight obtained its **EGS License, Docket No. A-2021-3027472**.

Following a recent acquisition, all energy brokerage activities in Pennsylvania will now be conducted by **Accenture LLP**, an affiliate of Insight. Accenture LLP holds the required License to operate as **Electric Generation Supplier (broker/marketer) in Pennsylvania – (Docket No. A-2014-2428714)**.


We confirm that all client contracts have been assigned to Accenture LLP. As of this date, Insight has no active consumers for its electricity or natural gas brokerage services in Pennsylvania, and therefore no client notifications were required or issued. There are also no outstanding obligations related to these services. We are not aware of any pending or active informal or formal complaints under review with the Commission.

We have served abandonment packages on the five statutory agencies and applicable distribution companies/utilities as required. Please refer to Exhibit A- Certificate of Service. 
