AMENDMENT TO APPLICATION

Request to Amend Authority to Paratransit Service

True Companions LLC, by and through its authorized representative, Thomas Morrin, respectfully submits this Amendment to its pending application before the Pennsylvania Public Utility Commission under Docket No. **A-2026-3061885**.

The Applicant hereby requests to amend its pending application from Motor Contract Carrier of Passengers authority to Paratransit Service authority.

This amendment is submitted following clarification received from Commission staff regarding the operational limitations of Contract Carrier authority and the suitability of Paratransit authority for the Applicant's intended transportation model.

True Companions LLC intends to provide non-emergency, wheelchair-accessible paratransit transportation services for individuals requiring mobility assistance, including elderly passengers, wheelchair users, and individuals requiring transportation to and from medical appointments, rehabilitation services, healthcare facilities, and related destinations.

The Applicant understands that Paratransit authority is more appropriate for its intended service model because the business is not seeking to operate solely for one designated contract entity, but rather to provide structured wheelchair-accessible transportation services within an approved service territory.

Revised Service Territory

The Applicant hereby amends its proposed service territory to the following counties within the Commonwealth of Pennsylvania:

- **Philadelphia County**

- **Delaware County**

The Applicant confirms that trips will originate from Philadelphia County and Delaware County and may proceed to points within the Commonwealth of Pennsylvania, including return transportation, consistent with the scope of Paratransit authority.

The Applicant withdraws Montgomery County, Chester County, and Bucks County from the proposed operating territory for purposes of this amendment.

Revised Service Description

True Companions LLC seeks authority to provide non-emergency wheelchair-accessible paratransit transportation services originating in Philadelphia County and Delaware County, Pennsylvania, to points within Pennsylvania and return.

The service will be pre-arranged and designed to support passengers requiring assisted transportation, including wheelchair-bound individuals and persons with mobility limitations.

Operational Readiness

The Applicant confirms that its operational model remains focused on safe, reliable, and compliant transportation. The Applicant will maintain appropriate driver qualification standards, vehicle safety procedures, recordkeeping practices, and insurance compliance as required by the Commission.

The Applicant further understands that required insurance filings, including any applicable Form E filing, must be submitted by the insurance carrier directly to the Commission before operations may commence.


Request

Based on the foregoing, True Companions LLC respectfully requests that the Commission accept this amendment and continue processing the application under Paratransit Service authority with the revised territory of Philadelphia County and Delaware County.

STATEMENT OF SERVICE NEED

True Companions LLC respectfully submits this Statement of Service Need in support of its amended application for Paratransit Service authority under Docket No. **A-2026-3061885**.

The Applicant seeks authority to provide non-emergency, wheelchair-accessible paratransit transportation services originating within Philadelphia County and Delaware County, Pennsylvania, to points within the Commonwealth of Pennsylvania and return.

The requested authority is intended to address the transportation needs of individuals requiring mobility assistance and structured non-emergency transportation services, including:

- Elderly individuals
- Wheelchair-bound passengers
- Mobility-impaired persons
- Individuals requiring transportation to medical appointments, rehabilitation services, healthcare facilities, and related care destinations


The Applicant has identified a need for reliable and professionally coordinated transportation services within the proposed territory, particularly for passengers requiring wheelchair-accessible transportation and mobility support.
