RJoseph Transportation Services LLC respectfully submits the following response to the Request for Information issued by the Pennsylvania Public Utility Commission regarding the above-referenced application.

1.a. Driver's License Checks

RJoseph Transportation Services LLC will conduct driver's license checks and motor vehicle record (MVR) reviews at least once every 12 months for all active drivers, strictly adhering to the annual review requirements of 52 Pa. Code §37.204 and 49 CFR §391.25.

1.b. Criminal Background Checks

Following the mandatory initial background screening prior to hiring, RJoseph Transportation Services LLC will conduct recurring criminal background checks for all drivers annually (once every 12 months) to ensure ongoing compliance with 52 Pa. Code §31.134 and 49 CFR §382.301.

1.c. Drug and Alcohol Testing & Record Keeping

RJoseph Transportation Services LLC will conduct drug and alcohol testing under a mandatory random testing program quarterly, alongside immediate pre-employment, post-accident, and reasonable-suspicion testing as required by 52 Pa. Code §37.204. In strict compliance with 49 CFR §382.401, all verified positive controlled substance test results, alcohol test results with a concentration of 0.02 or greater, and documentation of refusals will be maintained for a minimum of five (5) years. Negative and clean test results will be maintained for a minimum of one (1) year.

2. Financial Statement

Attached is a copy of an actual, recent bank statement issued under the business name RJoseph Transportation Services LLC.

Wheelchair Transportation Services

RJoseph Transportation Services LLC acknowledges the Commission's notice regarding wheelchair transportation services. The company understands that a certificate will not authorize wheelchair transportation services until an appropriate wheelchair-accessible vehicle is presented to the Commission. Upon receiving operating authority, RJoseph Transportation Services LLC intends to acquire a wheelchair-accessible vehicle equipped with the required accessibility equipment. Prior to providing any wheelchair transportation services, the company will submit the vehicle information and supporting documentation to the Commission and will ensure full compliance with all applicable Pennsylvania Public Utility Commission requirements.
