B. i. We conduct a criminal background check prior to hire and annually thereafter.  
ii. We keep background checks in a confidential file separate from the individual's general personnel file.

C. i. We perform drivers license/history checks prior to hire and annually thereafter. We will perform a check following an accident, insurance claim, moving violation etc.  
ii. We keep license/history checks in the individual driver qualification file.

4. We keep up with preventative maintenance for our trucks by having drivers complete the daily inspection list before and after use. Approximately between 5,000-7,000 miles we have a PM done- oil change, fluid check, lift gate check, brake and suspension check, tire check, safety equipment check etc. We also have DOT inspections done annually.

5. To ensure our vehicles comply with Pennsylvania vehicle equipment standards at all times, we have schedules for our PMs for each truck, if there is a report in the daily inspection that has to do with safety/driving functionality we put the truck out of service until the issue is assessed and fixed. We keep records of repairs and make sure the truck is functioning safely after repair before the truck is put back in service.
