Dear Secretary Matthew L. Homsher:

My office represents Romesberg Trucking, Inc., regarding the Tentative Order of Cancellation of its Certificate of Public Convenience. Please accept this letter as its comments and contesting of the Tentative Order. Romesberg Trucking contests the Tentative Order that is simply based upon alleged inactivity of hauling for third parties. Romesberg Trucking, Inc. is an active business and hauls its own products and equipment on nearly a daily basis.

The Tentative Order of Cancellation appears to be based solely upon the fact that Romesberg Trucking has not billed for and demonstrated that it has conducted business with third party consumers for the past two (2) years. The demonstration of third party earnings does not reveal, however, the fact that Romesberg Trucking operates its trucks on nearly a daily basis and that they continue to maintain its fleet in a proper and safe condition. The purposes of the requirement that services be operated continuously and without unreasonable interruption should not be based solely upon a review of third party income as it simply fails to recognize the continued operations of its trucks for its own purposes which does not reflect separate income earnings. Based upon our research, the requirement for service to be **reasonably continuous and without unreasonable**

interruptions or delay simply establishes a legal standard for utility reliability, ensuring that public utilities maintain infrastructure and respond promptly to service issues while protecting consumer interests. This requirement does not, however, establish that services are required to be supplied to a third party such that the same is reflected as earned income. Given the fact that Romesberg Trucking, Inc., in fact, maintains a reliable and safe service that is available for third party engagement, we respectfully request that the Tentative Order of Cancellation of the Certificate of Public Convenience of Romesberg Trucking, Inc. be rescinded.

In the event that the request to rescind the Tentative Order cannot be honored, we request a hearing to address the proposed cancellation of the certificate of public convenience. Regarding scheduling, we ask that you contact my office at the above address or phone to determine dates that we would mutually be available to have any required hearing. If you feel that a phone conversation or other communication could result in a resolution of this matter, I ask that you please contact me.

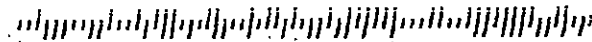

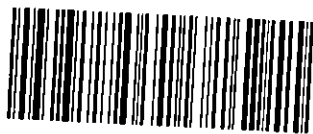
