
**SUPPLEMENTAL COMMENTS

NOW COMES Arrive In Style Transportation Co., Inc. ("Arrive in Style") and hereby submits these Supplemental Comments to the Comments previously submitted in this matter, on May 8, 2026. The purpose of the supplement is to bring additional information to the attention of the Commission, in the form of records of receipts and payments received by Arrive in Style for trips within Pennsylvania. That information is included in **Attachment A** hereto which contains receipts for trips in 2024 and 2025 for Arrive in Style. These receipts confirm the revised revenue figures that were submitted to the Commission for those years. The total amount of revenue reported is \$11,398.
