

NOTE 5 - Minimum Transportation Charge: Sundays and Holidays (any hour): 5 hours plus applicable travel time charge at rates named in Columns 1 and 2. Saturdays (any hour): 3 hours plus applicable travel time charge at rates named in Columns 1 and 4. Weekdays (any hour): 3 hours plus applicable travel time charge at rates named in Columns 1 and 3. Please note that carrier will not assess a minimum charge when shipment is 400 Cubic Feet (2800 Pounds) or less.

NOTE 6 - When stairs are part of the move, carrier will assess an additional fee of \$40.00 per mover and when a long carry is part of the move, an additional charge of \$35.00 per movers will be assessed. When the shipment includes marble, glass, travertine, etc., a fragile item fee of \$75.00 per item will be added to all other applicable charges.

NOTE 7 - When bulky items are included in the shipment, additional handling charges as noted below will apply:

Safe (any size) - \$1.00 per pound, Spinnet or Console Piano - \$200.00, Upright or Baby Grand Piano - \$400.00, Grand Piano - \$600.00, Medium Fishtank - \$75.00, Large Fishtank - \$200.00, Extra Large Fishtank - \$400.00, Motorcycle (under 300cc) - \$250.00, Motorcycle (301cc to 600cc) - \$500.00 and Motorcycles (over 600 cc) - \$1000.00.

NOTE AA - Travel charge to be based on the combined drive time from the carrier's terminal to the first point origin and from the final destination back to the carrier's terminal using Google Maps, MapQuest, TruckRouter or a similar software program designed to calculate mileage, using the hourly rates on Page 63-E-7 and charged in increments of one-half hour (30 minutes).
