Request for Information

1.) You list the following commodities under Question 10 of the application: General Freight.

Please explain in detail as to who hires you for the transport of these items, describe these items and explain how they are not related to your work as an excavating company.

2.) Transportation of S & S Construction LLC's machinery and construction materials used on its job sites are exempt from PUC regulation and oversight. If this is the case, then you should withdraw your application.

NOTE: The Pennsylvania sales tax exemption is not a valid reason to seek PUC authority. To qualify, you must provide for-hire transportation services that fall under PUC jurisdiction. All revenue reported on your annual PUC Assessment Report is subject to audit. If every transportation service you provide is exempt from PUC oversight, you should not apply for PUC authority.

It is unlawful to claim or use sales tax –exempt status when you are not providing qualifying utility services. Individuals or entities that do so may face legal action and prosecution.
