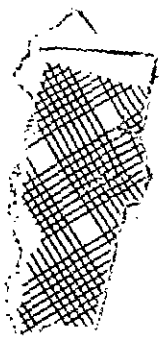
Dear Secretary Homsher:

The purpose of this correspondence is to respond to Pennsylvania Public Utility Commission staff data requests on the Usource LLC to NextEra Advisory, LLC name change request, at the above referenced docket number. Usource, LLC's name was legally changed to NextEra Advisors, LLC in Delaware but the Pennsylvania Secretary of State required use of the name NextEra Advisory, LLC due to the unavailability of the NextEra Advisors, LLC name in Pennsylvania. Customer contracts will say NextEra Advisors, LLC doing business in Pennsylvania as NextEra Advisory, LLC. Enclosed please find: (1) the Certificate of Service demonstrating proof of service of the name change request; (2) an updated **confidential** bond rider listing the company's new name; and (3) a customer notice for the name change which was sent to all customers. 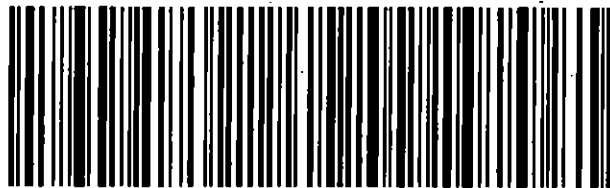
