**ORDER GRANTING JOINT STIPULATION AND MOTION
FOR ADMISSION OF EVIDENCE INTO THE RECORD**

On May 20, 2026, Philadelphia Gas Works (“PGW”), the Bureau of Investigation and Enforcement (“I&E”), the Office of Consumer Advocate (“OCA”), the Office of Small Business Advocate (“OSBA”), the Philadelphia Industrial and Commercial Gas Users Group (“PICGUG”), Grays Ferry Cogeneration Partnership and Vicinity Energy Philadelphia, Inc. (“Vicinity”), the Coalition for Affordable Utility Services and Energy Efficiency in Pennsylvania (“CAUSE-PA”), and Tenant Union Representative Network (“TURN”) (collectively “Stipulating Parties”), submitted a Joint Stipulation for Admission of Evidence in this proceeding on remand and Motion to Admit Into the Record said Testimony and Exhibits, without a hearing, based on the pre-served verifications executed by each witness identified for each testimony listed below:
