NOTICE OF ABANDONMENT

On May 21, 2026, the Pennsylvania Public Utility Commission issued an Order granting an application by Peoples Natural Gas Company LLC (“Peoples”) seeking a Certificate of Public Convenience authorizing it to abandon natural gas service to Two Active Customers and Two Inactive Premises located in Tyrone Borough, Blair County, Pennsylvania.
