Please be advised that FirstEnergy Pennsylvania Electric Company (“FE PA”) has communicated the withdrawal of its objections to Armstrong Telecommunications, Inc.’s (“Armstrong”) Set I Interrogatories in their entirety and has agreed to provide responses to each interrogatory in Set I. Accordingly, Armstrong withdraws its Motion to Compel filed on June 8, 2026, and no action by Your Honors is needed to resolve FE PA’s withdrawn objections at this time.

However, Armstrong must note FE PA’s failure to timely respond to Armstrong’s Set I interrogatories. FE PA’s responses were due on Monday, June 8, 2026. As of the filing of this letter, Armstrong has not received a single response. FE PA’s continued failure to respond is in direct violation of the discovery modifications agreed to by the parties and ordered by Your Honors. Armstrong reserves the right to file an appropriate motion to compel based on further unjust delays or as to substance of FE PA’s responses, if necessary.
