Request for Information

1.) Question #10 of the application.

Your proposed service area includes six counties (Allegheny, Armstrong, Beaver, Butler, Washington, and Westmoreland) with no proven company-owned vehicle, no verified cash assets and only one facility. The Commission will not approve authority requests that do not demonstrate the ability to provide safe, efficient, and reasonable service. Comprehensibly explain how you will be able to provide the proposed service.

2.) Question #5 of the Verified Statement.

These questions are not optional. If you are asked a multi-part question, it requires a response which addresses each part. Your responses are expected to be fully responsive so that the Commission may evaluate your fitness to provide the proposed service.

A.) Again, how often will criminal history checks be done and what are disqualifications of employment?

B.) You have also failed to describe your driver training program beyond saying that one will be offered. Please explain your program in detail.

3.) Question #8 of the Verified Statement.

Provide the commercial insurance quotes mentioned to get a fuller picture of LLC's financial position.

4.) Financial Position.

Approval of your application cannot be considered with no company assets. Again, the information provided should be limited to those funds dedicated to operating this business, there should be no comingling of personal funds or assets.

A.) Please submit a corrected, improved Balance Sheet reflecting acceptable updates.

- To show improved financial fitness you should show a substantial cash asset amount to cover vehicle maintenance, insurance coverage, assessments, possible fines, etc.
- Any assets which may need transferred to MJM Luxury Ridez LLC should happen prior to presenting them in the balance sheet.
- Now is the time to transfer suitable funds into the company name.

B.) Lastly provide supporting documentation for the improved balance sheet. Acceptable means of support include current copies of bank statements or notarized/official statements of account balances provided by bank officers (with current contact information) in the name of MJM Luxury Ridez LLC. (account numbers may be redacted).

C.) Include proof of ownership of the vehicle(s) with a copy of a title and/or registration in the name of the applicant (MJM Luxury Ridez LLC) or remove them from the Balance sheet.

- You are encouraged to enlist professional financial assistance if you have trouble in constructing your statement of financial position.

**FYI-**You are now expected to be familiar with your related requirements of title 52.

As discussed on our phone conversation, a Transportation Network Company cannot use PUC certified carriers and/or a vehicle that is registered commercial.

**Note:** It is the responsibility of the applicant seeking motor common carrier authority to demonstrate that it possesses the financial ability to provide the proposed service. As per 52 Pa. Code §41.14, applications may be denied if the applicant fails to satisfy fitness standards. Be advised that additional corrections may not always be requested; therefore, prior to submitting your responses, your consultation with an attorney or financial expert familiar with Commission regulated Motor Carrier-related proceedings is highly encouraged. It is in your best interest to provide accurate, complete, and timely responses.
