**INTERIM ORDER REQUIRING THE PARTIES TO CONFER AND PROVIDE  
AVAILABLE HEARING DATES**

On April 28, 2026, a Further Call-In Telephonic Hearing Notice was issued scheduling a hearing in this matter for August 12, 2026 at 10:00 a.m. On April 29, 2026, a Prehearing Order was issued advising on the rules that would govern the hearing scheduled for August 12, 2026. However, due to a scheduling conflict, the Presiding Officer is no longer available for the scheduled hearing date. As such, a Hearing Cancellation Notice was issued on June 11, 2026 advising the parties that the August 12, 2026 hearing was canceled.

Accordingly, the parties are directed to comply with the following:

1. **ON OR BEFORE July 13, 2026**, the Parties shall confer in an attempt to agree upon new proposed dates to reschedule the telephonic hearing in this case between the period of October 2026 and December 2026 and each Party or the Parties jointly shall file a status report in this proceeding and serve the opposing Party and the undersigned Presiding Officer. The status report shall identify all dates in which the Parties and their witnesses will be able to provide testimony in this proceeding between the period of October 2026 and December 2026. The Parties shall confer after contacting their witnesses and attempt to agree upon proposed dates for the hearing. The Parties shall identify at least three different proposed hearing dates. It is anticipated that the hearing can be concluded in one day. If the parties do not agree upon a hearing date(s), each Party should submit a separate letter or status report, on or

before July 13, 2026, to include at least three proposed dates from the time period provided above.

2. Absent receipt of this information, a hearing date will be established by the undersigned Presiding Officer and the Parties and their witnesses will make themselves available at the scheduled date(s) and time(s).
