On June 9, 2026, UGI Utilities, Inc. - Electric Division filed a Petition with the Commission for Approval to Modify its Default Service Supplier Master Agreement (SMA) in order to allow Global Systematically Important Banks (GSIBs) to participate in UGI's wholesale default supply auctions.
