Good morning,

I will go ahead and grant UGI's second request for continuance. However, no other requests for continuances will be granted for the Respondent in the future.

Trying to accommodate both parties' preferences, I shall reschedule this hearing on the second half of January 2026. A Hearing Cancellation/Reschedule Notice shall be issued soon, notifying the parties of the exact time and date.

This continuance will provide the Complainant with an additional opportunity to obtain legal representation in this matter. As stated in my Interim Order issued on October 16, 2025, if the Complainant, Matterns Floral, is a limited liability Company (LLC) or a corporation, it must have an attorney, licensed to practice law in Pennsylvania or admitted *pro hac vice*, enter his or her appearance in this matter. Because I am granting UGI's second request for a continuance of the hearing, I shall also extend the deadline for the Complainant to obtain legal representation from November 25, 2025 to new hearing date. Failure to do so will result in dismissal of these consolidated matters.

An Order memorializing the above will be issued shortly.
