**Dear MOTOR CARRIER COMPLIANCE CHIEF,**

We are writing to formally petition for permission from the Pennsylvania Public Utility Commission for replacement of traditional taximeters with alternative devise that comply with the requirements set forth in 52 Pa. Code §29.314 (b) (9).

We recognize that the Commission adopted several new regulations in 2017 which reflected the desire of taxi companies to utilize alternative devises such as tablet and cell phone apps, and we have been using such alternative devises for some time. The devices that we use meet the requirement established for meters, including accuracy and consumer information requirements. Our software-based taximeters operate by using a GPS signal to measure distance traveled and calculate fares.

Our devices are more effective than standard taximeters because they allow for taxi trips to be priced according to metered rates, upfront pricing, or dynamic pricing, with safeguards to ensure consumer protections for taxis that are physically hailed in the street or at taxi stand those that hailed electronically through an app or online.
