Dear Secretary Chiavetta:

Pursuant to Administrative Law Judge F. Joseph Brady's Interim Order Granting Joint Motion for Stay (the "Stay Order"), issued February 6, 2023, the Delaware County Regional Water Quality Control Authority ("DELCORA") is filing and serving this written status report detailing the procedural status and litigation schedule for the Complaint for Declaratory Judgment filed in the Court of Common Pleas, Delaware County, in Docket No. CV-2023-000494 ("Declaratory Judgment Matter") and also for the Receiver for the City of Chester's Motion of Debtor Pursuant to Section 362 of the Bankruptcy Code for Entry of an Order Enforcing the Automatic Stay of Proceeding Pending Before the Pennsylvania Public Utilities [sic] Commission ("Bankruptcy Matter").

### **DELCORA Complaint for Declaratory Judgment**

In this proceeding, Aqua filed preliminary objections to DELCORA's Complaint. The Court scheduled a hearing for October 12, 2023, however the presiding Judge cancelled the October 12th hearing and advised the parties that hearings on this matter would be postponed until a decision was rendered in the pending Appeal in Commonwealth Court at 134 7 CD 2022, regarding the jurisdiction of the Court of Common Pleas. The Commonwealth Court initially scheduled this matter for oral argument on May 7, 2024, but notified the parties on April 29, 2024, that the Court would decide the matter on the submitted briefs.

On June 4, 2024, the Commonwealth Court entered an Order affirming and vacating portions of the Order of the Court of Common Pleas of Delaware County, dated September 13, 2022, in Case No. CV-2020-003185.



On December 3, 2024, the Delaware Court of Common Pleas issued an order sustaining Aqua's preliminary objections and dismissed DELCORA's complaint. In Judge Dozer's opinion, he held that, "there is no uncertainty, case or controversy as a matter of law, and therefore declaratory that there is relief is unnecessary and inappropriate."

DELCORA did not seek to amend its complaint or file an appeal challenging the dismissal of its Complaint. As such the December 3rd Order is final and unappealable.
