RESPONDENT’S PETITION FOR EXTENSION OF TIME

Respondent All My Sons of Pittsburgh, LLC, by and through its counsel, Joshua R. Miller, and the law firm of PION, NERONE, GIRMAN & SMITH, P.C., hereby submits the following Petition for Extension of Time, in support thereof, states as follows:

1. Respondent All My Sons of Pittsburgh, LLC, (“AMS”) respectfully requests a 20-day extension to Answer the Formal Complaint filed by Pennsylvania Public Utility Commission, Bureau of Investigation and Enforcement (“Complainant”) in the above-referenced proceeding.
2. AMS was served with the Complaint on May 8, 2026. The regulatory deadline for filing responsive pleadings is 20 days, making AMS’ responsive pleadings due on or before May 28, 2026. *See* 52 Pa. Code § 5.61(a).
3. A previous extension was granted by this Commission on June 1, 2026, allowing AMS a 20-day extension to respond to the Formal Complaint.

4. AMS believes an additional 20-day extension is necessary to accommodate further fact finding related to the allegations in the Complaint, as well as to allow AMS and the Complainant to pursue further settlement discussions, which are currently ongoing.


5. AMS has discussed this request with the Complainant and understands that the Complainant agrees with the requested extension.

6. If the extension is granted, AMS will file and serve responsive pleadings to the Formal Complaint on or before July 7, 2026, if this matter remains unresolved.

WHEREFORE, Respondent All My Sons of Pittsburgh, LLC, respectfully requests that an additional extension of twenty (20) days be granted for AMS to respond to the Formal Complaint.
