**JOINT MOTION TO CONSOLIDATE FORMAL COMPLAINT WITH
PEOPLES NATURAL GAS COMPANY LLC'S RATE PROCEEDING**

1. On December 10, 2025 Complainant, Ben Troyer Jr. ("Complainant") filed a Formal Complaint against Peoples Natural Gas Company LLC ("Peoples") regarding Peoples rate Weather Normalization Adjustment ("WNA").
2. In his complaint, Complainant objected to Peoples billing him a WNA charge and requested as relief that Peoples remove rate WNA from Complainant's natural gas distribution bill.
3. On June 17, 2026, a resolution conference was held between Complainant, Peoples and the Office of the Administrative Law Judge's ("OALJ") Mediator, Teri-Lee Rhoades.
4. Peoples explained that it has a pending base rate proceeding at issue before the Commission at Docket No. R-2026-3060855. In that proceeding interested stakeholders can challenge Peoples' requested base, non-gas supply rates, which includes the WNA.
5. Complainant and Peoples both agree that it is appropriate to consolidate Complainant's Formal Complaint at Docket No. C-2025-3059337 with Peoples base rate proceeding at Docket No. R-2026-3060855.
6. Peoples and Complainant now jointly and respectfully request the OALJ division to consolidate Docket No. C-2025-3059337 with and into Docket No. R-2026-3060855.
7. Wherefore, Peoples and Complainant respectfully move pursuant to Section 5.81 of the Commission's Rules and Regulations for Formal Proceedings for the consolidation of the Formal Complaint matter at Docket No. C-2025-3059337 with and into Peoples pending base rate proceeding at Docket No. R-2026-3060855. Once consolidated, the Formal Complaint Docket at C-2025-3059337 should be marked "closed".
