On June 16, 2026, the Pennsylvania Public Utility Commission (Commission) received RBD Retail Power, LLC's Application for an Electric Generation Supplier (EGS) license as a broker/marketer. Data Requests

1. Reference Application, Section 7.b, Financial Fitness – The Applicant stated that it is a new startup and does not have independent financial statements at this time. The company indicated that it is providing a bank statement in lieu of financials. However, the submitted bank statement is missing the name of the financial institution and other required information. Please provide a bank statement that includes the name of the financial institution and all required details, consistent with the bank statements submitted for JAZ Ventures, L.P. In addition, please provide further evidence of the Applicant's financial fitness in the name of the Applicant. Such documentation may include, but is not limited to, a notarized guarantee or agreement demonstrating that the Applicant's parent company assumes full financial responsibility for RBD Retail Power, LLC's electric operations within the Commonwealth of Pennsylvania. Any parent company guarantee should clearly identify the parent entity and describe the extent of its financial obligations and commitments on behalf of the Applicant. If the company elects to provide a parental guarantee, the parent company's income tax returns or audited financial statements for the most recent two years should also be submitted.
2. Reference Application, Section 7.f, Taxation – Applicant is required to provide the eight-digit sales tax license number obtained from the Pennsylvania Department of Revenue. Please submit an updated Tax Certification Statement with the eight-digit sales tax license number.
