Section 8(a): TLG has recently received confirmation of its membership with MISO. TLG is including proof of membership through the executed MISO Membership Agreement.

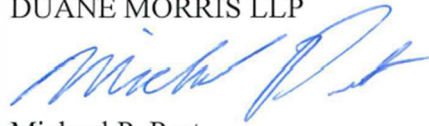
