INTERIM ORDER
LATE-FILED EXHIBITS

A Telephonic Public Input Hearing was held on July 29, 2026 at 1:00 p.m. The hearing convened as scheduled with counsel for Veolia Water Pennsylvania, Inc. (“Veolia”), the Office of Small Business Advocate (“OSBA”), the Office of Consumer Advocate (“OCA”) in attendance. At the hearing, Lauren Silvers offered testimony and proposed 12 exhibits for the record. The exhibits were not submitted in accordance with the Public Input Hearing Notice issued on June 24, 2026 or the Corrected Public Input Hearing Notice issued on June 25, 2026. Therefore, Ms. Silvers’ exhibits are deemed to be late-filed exhibits. Attorney Dawn Kurtz Crompton (“Attorney Crompton”), representing Veolia, objected to Ms. Silvers’ Exhibits on the basis several grounds.

Because the exhibits were late-filed, I advised on the record that the parties would have seven days to object to the exhibits and then seven days to respond to any objections. Subsequently, off the record, Attorney Crompton requested that the period be extended to ten days to accommodate time to get the transcript. Neither OSBA nor OCA objected to the change. Therefore, the parties shall have ten days to make any objections to Ms. Silvers’ exhibits.

If an objection is filed, the other parties shall have ten calendar days after the objection(s) is filed to file a written response. Any response to the objection(s) is to be served on opposing counsel and the undersigned. My email address is callenswor@pa.gov.

If no objection is filed, then Silvers' Exhibits 1 through 12 will be admitted into the record without further action.

THEREFORE;

IT IS ORDERED:

1. That any objections to Silvers' Exhibits 1 through 12 must be filed in writing on or before August 10, 2026.

2. That if an objection is filed, the other parties shall have ten calendar days from the filing of the objection to file a written response.

3. That if no objection is made, Silvers' Exhibits 1 through 12 are admitted into the record in the matters of Office of Small Business Advocate v. Veolia Water Pennsylvania, Inc. at Docket No. C-2025-3058757 and Office of Consumer Advocate v. Veolia Water Pennsylvania, Inc. at Docket No. C-2025-3058865.
