The purpose of this correspondence is to request a new license be issued to show that Symmetry Energy Solutions, LLC has changed its name to NextEra Energy Services Gas, LLC d/b/a Symmetry Energy Solutions. The entity name change has been filed with the: (1) Delaware Department of State, as reflected in the enclosed State of Delaware Certificate of Amendment (**Attachment A**); and (2) Pennsylvania Department of State, as reflected in the enclosed Amendment of Foreign Registration Statement (**Attachment B**). 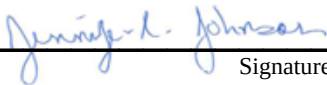

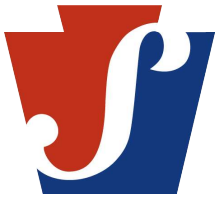
