Per the PUC website, insurance forms E & H for this company have been submitted and accepted.

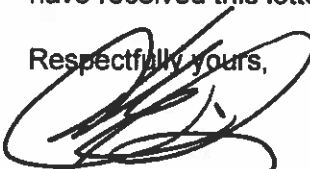
