PETITION TO INTERVENE OF
MID-ATLANTIC INTERSTATE TRANSMISSION, LLC

Pursuant to Section 52 Pa. Code §§ 5.72–5.74, Mid-Atlantic Interstate Transmission, LLC (“MAIT”) hereby files this Petition to Intervene (“Petition”) in the above-captioned proceeding. In support of this Petition, MAIT states as follows:

I. INTRODUCTION

On May 21, 2026, Transource Pennsylvania, LLC, (“Transource PA”) filed an Application pursuant to 52 Pa. Code Chapter 57, Subchapter G, for approval of the siting and construction of a new electric substation and double-circuit Rice-Ringgold 230 kilovolt (“kV”) electric transmission line and related facilities located in a portion of Franklin County, Pennsylvania (“Application”) at the Pennsylvania Public Utility Commission (“PUC” or “Commission”).

Notice was published in the *Pennsylvania Bulletin* on June 3, 2026, directing that formal protests and petitions to intervene be filed with the Commission on or before August 12, 2026.

MAIT is a certificated public utility providing interstate electric transmission service in Pennsylvania.

As proposed, MAIT does not take a position with regard to the Application. As the Commission proceeding progresses, however, other intervenors may propose changes to the Application that could impact MAIT. Accordingly, MAIT files this Petition in the above-referenced proceeding consistent with the Commission's regulations at 52 Pa. Code §§ 5.72–5.74.

II. ELIGIBILITY TO INTERVENE

The Commission's regulation at 52 Pa. Code § 5.72 permits a petition to intervene to be filed by a "person claiming a right to intervene or an interest of such nature that intervention is necessary or appropriate to the administration of the statute under which the proceeding is brought." 52 Pa. Code § 5.72(a).

A party is eligible to intervene under this section where it can demonstrate "an interest which may be directly affected and which is not adequately represented by existing participants, and as to which the petitioner may be bound by the action of the Commission in the proceeding." 52 Pa. Code § 5.72(a)(2).

The Commonwealth Court held that intervention is proper where a party's interest in the proceeding is "substantial, immediate, and direct." *George v. Pa. Pub. Util. Comm'n*, 735 A.2d 1282, 1286 (Pa. Commw. Ct. 1999); *see also Re: Equitable Gas Co.*, 76 Pa. P.U.C. 23 (Opinion and Order dated Jan. 16, 1992).

Through its Application, Transource PA is seeking approval from the Commission to construct a 230 kV transmission line extending from the new Rice Substation to the Pennsylvania-Maryland border in Franklin County, Pennsylvania. Application, p. 2. Transource PA is proposing

to construct this line as the Pennsylvania portion of the 9A West Project,¹ previously approved by PJM Interconnection, LLC (“PJM”). *Id.*

The Application that began the instant proceeding addresses the siting issues associated with the Pennsylvania portions of the 9A West Project. The Application proposes the location and construction of a 230 kV line approximately 24.4 miles in length. *Id.* at 5.

If the Pennsylvania portions of the 9A West Project are approved, MAIT will be required to make relay upgrades at its substation facilities in Middletown, Pennsylvania. Similarly, any changes to the Pennsylvania portions could impact the scope of the required work and would cause MAIT to reevaluate the potential impacts of such changes on its facilities and operations.

Accordingly, MAIT has an interest in this proceeding that is substantial, immediate, and direct, and which may not be adequately represented by other participants in this proceeding. MAIT’s upcoming upgrade work will be necessary to ensure continued reliability once the 9A West Project is constructed. In addition, the review and disposition of the Application could modify the scope of MAIT’s upgrade work and would require MAIT to conduct additional studies of the impact of the 9A West Project on MAIT’s operations and facilities. As such, any modifications made to the 9A West Project during this proceeding will directly impact the future work of MAIT. No other party may adequately represent MAIT’s interests in this proceeding as no other party is responsible for the same work resulting from the implementation of Baseline Upgrade Numbers b2743 and b2752. MAIT is uniquely impacted by the developments and outcome of this proceeding.

¹ The 9A West Project involves the siting and construction of a 230 kV transmission line connecting the existing Ringgold Substation in Washington County, Maryland and the new Rice Substation in Franklin County, Pennsylvania. Application at 5.

As proposed, MAIT does not take a position with regard to the Application. As the Commission proceeding progresses, however, other intervenors may propose changes to the Pennsylvania portions of the 9A West Project that would impact the scope of MAIT's work and operations. To the extent changes are proposed, MAIT is seeking party status to monitor the proposed changes and modify its future operations and work accordingly.

For these reasons, MAIT respectfully requests that the Commission grant this Petition to Intervene.

III. CONCLUSION

WHEREFORE, Mid-Atlantic Interstate Transmission, LLC respectfully requests that the Commission grant its Petition to Intervene.
