Dear Secretary Homsher:

NextEra Advisory, LLC d/b/a Usource respectfully requests that the Pennsylvania Public Utility Commission reflects its name change in its records and issue EGS and NGS licenses in the name of NextEra Advisors, LLC. The name change stems from the entity name NextEra Advisors, LLC, recently becoming available in Pennsylvania. The entity name change has been filed with the: (1) Delaware Department of State, as reflected in the enclosed State of Delaware Certificate of Amendment (changing entity's prior name Usource, LLC to NextEra Advisors, LLC) (**Attachment A**); and (2) Pennsylvania Department of State, as reflected in the enclosed Amendment of Foreign Registration Statement (**Attachment B**).

The Federal Employer Identification No. (FEIN) did not change. The name change will not affect the rates, terms or conditions of service provided.

The company serves as a broker to only commercial and industrial customers in Pennsylvania. A customer notice regarding a name change from NextEra Advisory, LLC to NextEra Advisors, LLC, would unnecessarily cause customer confusion. Accordingly, we request a waiver of the customer notice requirement to minimize customer confusion regarding the name change. The phone numbers and office locations for the business will remain the same.

Enclosed is an original **confidential** bond rider listing the company's new name (**Attachment C**).

The confidential bond rider is being provided to the Commission under seal, and the PUC SEC BUR requested that it be maintained in a non-public folder.
