RULES AND REGULATIONS

Advance Reservations: Advance reservations must be made prior to the service being rendered.

Hourly Rates: Rates begin from the time the vehicle leaves the carrier's place of business and end at the time the vehicle returns to the carrier's place of business, except where the applicable schedule states otherwise.

Payment Policy: The carrier will accept COD only (Cash on Delivery). Cash, credit or debit cards (Visa, Mastercard, American Express, & Discover). No checks of any kind. Payment of estimate must be paid in full prior to offload. Carrier will have to be paid in full by shipper prior to re-delivery.

Deposit & Refund Policy: Up to 48 hours prior to the date of the scheduled move all deposits will be refunded to the shipper, minus a 25% cancellation fee.

Infestation: Any household goods transported by the carrier which have been infested with ants, termites, cockroaches, bed bugs, or any dangerous or disease-bearing insect, as a result of the condition of the shipper's premises, either at the origin or destination, may be refused.

Fumigation: Any household goods transported by the carrier which become infested as a result of the shipper's premises may be subject to charges for necessary vehicle fumigation.

Coverage Offered: The coverage provisions in this tariff are subject to the Pennsylvania Public Utility Commission's applicable authority and approval requirements.

RULES AND REGULATIONS (CONTINUED)

Impractical Operations: The carrier is not liable for the move, storage, or delivery when acts of God; war; civil disturbances; labor disputes; governmental actions; terrorism; utility or internet interruptions; severely inclement weather; inadequate or unsafe roads, highways, streets or driveways; major construction, repair, delays or detours; ferry, tunnel or bridge interruptions; major access obstructions; hazardous or dangerous materials; or situations where the moving crew is or might be endangered or threatened with physical harm make performance impractical, subject to applicable law.

Articles of Extraordinary Value: Items of extraordinary value, including jewelry, coins, cash, documented antiques, family heirlooms and documented artwork, will not be moved and/or stored unless accompanied by specific proof of insurance provided by the shipper in advance.

Articles: Conditionally Restricted: Perishable foods requiring refrigeration; plants over 20 lbs.; and any tool or machine unless the fuel has been emptied by the shipper.

Articles: Completely Restricted: The carrier will not ship exotic or domestic animals; hazardous materials; explosives; live ammunition; firearms and weapons of any type; or any items of extraordinary value, subject to applicable law and the carrier's written rules.

Information for Shippers / Estimate: The Commission-supplied Information for Shippers and Estimated Cost of Services forms shall be furnished as required. A written estimate must be furnished at least 48 hours before the move unless the shipper agrees in writing to a shorter period.

Inventory: The carrier must complete a detailed inventory listing all items and their condition before loading. The shipper may waive the inventory requirement in writing for moves of 40 miles or less. A copy of the completed inventory must be provided before loading.

Bill / Receipt: The carrier shall provide a bill/receipt within 15 days after delivery, detailing all charges and containing the required inventory and Estimated Cost of Services documents.

Weight Tickets: For shipments over 40 miles, public-weighmaster weight tickets showing gross and tare weights shall be obtained and handled as required by Pennsylvania regulation.

SCHEDULE OF RATES — HOURLY MOVING

The hourly rate begins when the moving vehicle and crew arrive at the point of origin of the contracted move and ends when all goods are unloaded at the point of final destination, less scheduled breaks and/or vehicular breakdown, plus applicable travel time defined below.

Month-End / Month-Start: First three (3) days and last three (3) days of each month are charged Peak Friday–Sunday (+ Holidays) rates.

Overnight Holds: \$300.00 per truck, per night, not to exceed 3 nights.

TRAVEL TIME CHARGES

Standard Trip / Travel: One and one-half (1.5) hours of travel time at the applicable Standard Hourly Rate will be charged for all moves where total miles driven from the carrier's warehouse to origin and destination back to the carrier's origin does not exceed 40 miles.

Round Trip Travel: Any move traveling more than 40 miles from the carrier's warehouse to origin and destination back to the carrier's origin will be charged one hour (1 hour) at the applicable Standard Hourly Rate every additional 30 miles, in 15-minute increments.
