Riverfront Moving & Storage LLC.

- 1(A). There is no discrepancy regarding the ownership of Riverfront Moving & Storage LLC. The reference to "Loan to Shareholder" was an accounting classification appearing on the Company's financial statements and was not intended to indicate the existence of an additional shareholder, member, or owner.

Dante R. Reeves is the sole member and owner of Riverfront Moving & Storage LLC and holds 100% of the ownership interest in the Company. There are no other members, shareholders or owners.

- 1(B). There are no multiple members, shareholders or owners of Riverfront Moving & Storage LLC. Dante R. Reeves is the sole member and owner and holds 100% of the ownership interest in the Company.
- 1(C). Dante R. Reeves has no misdemeanor or felony convictions.

Riverfront Moving & Storage LLC

2(A). The entity referenced on the balance sheet as an "affiliate" is Reduced Price Real Estate LLC, which is a separate company under common ownership. Reduced Price Real Estate LLC is not a transportation company or licensed motor carrier.

The amounts classified as "Due from Affiliates" and "Due to Affiliate" represent intercompany loan transactions between Riverfront Moving & Storage LLC and Reduced Price Real Estate LLC and were classified as related-party transactions for accounting purposes.

The use of the term "affiliate" is strictly an accounting classification and does not indicate an operational or transportation-related affiliation between Riverfront Moving & Storage LLC and another transportation carrier. The companies do not perform work for one another, share customers, or operate in any related business capacity. Accordingly, Riverfront Moving & Storage LLC's statement that it has no affiliation with another carrier remains accurate.

2(B). Riverfront Moving & Storage LLC and Reduced Price Real Estate LLC remain under common ownership. However, there is no operational, business, or transportation-related relationship between the companies. Neither company performs work or provides services for the other. Their only financial relationship consists of the intercompany lending described in Responses 2(A) and 2(C).

2(C). Per the accountant's review, the \$33,736 balance reported as "Due to Affiliate" should have been combined with the "Due from Affiliates" balance. As a result, there is no net amount owed by Riverfront Moving & Storage LLC to an affiliate. Rather, the net balance represents an amount owed to Riverfront by its affiliate as a result of funds advanced by Riverfront.

Specifically, the "Due from Affiliates" balance of \$67,363 and the "Due to Affiliate" balance of \$33,736 should be offset against one another, resulting in a net "Due from Affiliates" balance of \$33,627.

This balance relates solely to funds loaned by Riverfront Moving & Storage LLC to Reduced Price Real Estate LLC, a company under common ownership. The use of the term "affiliate" is strictly an accounting classification used to identify related-party transactions. The companies do not conduct business with one another, do not provide services to one another, and have no operational relationship.

Accordingly, the balance represents an intercompany loan receivable and should not be interpreted as evidence of any transportation-related affiliation or business association.

- **2018 International** — registered in the name of Riverfront Moving & Storage LLC. The vehicle is subject to an equipment financing obligation with Western Equipment Finance. As of August 14, 2026, the current payoff amount is **\$3,352.53**.

- **2012 Ford** — registered in the name of Riverfront Moving & Storage LLC.

Copies of the current Pennsylvania vehicle registrations are attached as proof of ownership. Supporting documentation regarding the financing and current payoff amount for the 2018 International is also attached.

- 3(C). Not applicable. Riverfront Moving & Storage LLC currently owns vehicles available to provide the proposed transportation services, as demonstrated by the vehicle registrations submitted in response to Question 3(B).
- 3(D). Riverfront Moving & Storage LLC does not need to build additional capital in order to provide safe and reliable transportation services to the public. The Company has sufficient operating capital, vehicles, equipment, personnel, and other resources necessary to provide the proposed services. Accordingly, Riverfront Moving & Storage LLC intends to proceed with its application.

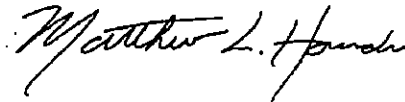

Section 3709 of the Pennsylvania Vehicle Code provides for a fine of up to \$300 for dropping, throwing or depositing, upon any highway, or upon any other public or private property without the consent of the owner thereof or into or on the waters of this Commonwealth from a vehicle, any waste paper, sweepings, ashes, household waste, glass, metal, refuse or rubbish or any dangerous or detrimental substance, or permitting any of the preceding without immediately removing such items or causing their removal.

For any violation of Section 3709, you may be subject to a fine of up to \$300 upon conviction, including any violation resulting from the conduct of any other persons operating, in possession of or present within the vehicle with your permission, if you do not with reasonable certainty identify the driver of the vehicle at the time the violation occurred.

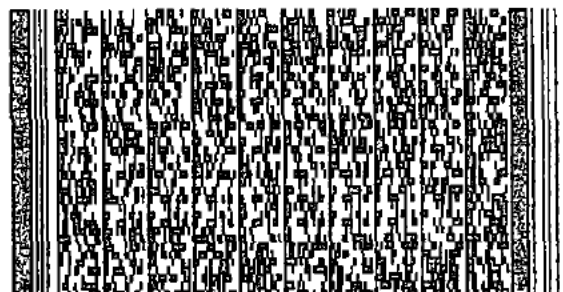
