ORDER
GRANTING JOINT STIPULATION AND ADMITTING EVIDENCE

On August 21, 2026, a Joint Stipulation for Admission of Evidence (“Joint Stipulation”) was filed by UGI Utilities, Inc. – Gas Division (“UGI”), the Pennsylvania Public Utility Commission’s (“Commission”) Bureau of Investigation and Enforcement (“I&E”), the Office of Consumer Advocate (“OCA”), and the Office of Small Business Advocate (“OSBA”) (hereinafter collectively referred to as the "Joint Petitioners").

Each of the Joint Petitioners stipulated to the authenticity of the testimonies and exhibits listed in the Joint Stipulation and requested that they be admitted into the record of this proceeding on the terms and conditions set forth in the Joint Stipulation. The Stipulating Parties also included verifications by each witness offering testimony in this proceeding. As this request is reasonable, it will be granted.

THEREFORE,

IT IS ORDERED:

1. That the Joint Stipulation for Admission of Evidence is granted.
