This filing is a request for an **INCREASE** in local hourly rates (both Peak Season and Non-Peak Season).

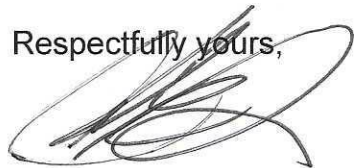
The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.
