**PETITION FOR AN EXTENSION OF TIME BY  
PENNSYLVANIA-AMERICAN WATER COMPANY**

---

Pennsylvania-American Water Company ("PAWC"), pursuant to Section 5.41 of the Rules of the Pennsylvania Public Utility Commission ("Commission") and the Commission's June 4, 2026 Opinion and Order ("Order"), hereby requests a 90-day extension of time to negotiate an Asset Purchase Agreement ("APA") with Rock Spring Water Company ("RSWC").

The Order directs PAWC to acquire the assets of RSWC and provides that PAWC and RSWC shall have three months from the entry date of the Order to negotiate an APA and file a petition to request approval of the purchase price and APA.<sup>1</sup> The Order further provides that PAWC may petition for additional time to negotiate the APA on or before the expiration of the three-month period.<sup>2</sup>

PAWC and RSWC are in active negotiations on a purchase price and APA. Consistent with the Order, PAWC respectfully requests a 90-day extension to continue its negotiations with RSWC. PAWC has conferred with counsel for RSWC, and RSWC does not object to the requested extension.

**WHEREFORE**, PAWC respectfully requests that the Commission grant this Petition and extend by ninety (90) days the deadline for PAWC to file its petition seeking approval of

the purchase price and the APA, thereby allowing PAWC and RSWC additional time to continue their negotiations.
