Dear Secretary McNulty:

In accordance with the Pennsylvania Public Utility Commission's PMO II Order,¹ Verizon Pennsylvania Inc. ("Verizon PA") is hereby notifying the Commission and the participants in the Pennsylvania Carrier Working Group that on December 15, 2006 the New York State Public Service Commission ("New York PSC") issued an order directing further revisions to the *Verizon Performance Assurance Plan New York* ("NY PAP"). A copy of the New York PSC's order is attached and also is available on the New York PSC's website at <http://www.dps.state.ny.us/fileroom>.

The December 15, 2006 New York PSC order approves Verizon New York Inc.'s October 25, 2006 compliance filing of a revised NY PAP, with one exception as to which the order directs a change to the compliance filing. In conjunction with its comments on the *Verizon Pennsylvania Inc. Performance Assurance Plan* ("revised PA PAP") submitted by Verizon PA on November 21, 2006, Verizon PA will submit a further revised PA PAP that incorporates into the revised PA PAP the change to the NY PAP directed by the New York PSC in its December 15, 2006 order. Incorporation of the December 15, 2006 New York PSC ordered changes into the revised PA PAP should not delay consideration of the revised PA PAP by the Commission.
